ROAD TRAFFIC (PRESCRIBED OFFENCES AND PENALTIES) (AMENDMENT)
REGULATIONS, 2019

IN EXERCISE of the powers conferred by section 181 of the Road Traffic Act, I,
RALPH JOOMA, Minister of Transport and Public Works, make the following Regulations—

Citation and commencement

1. These Regulations may be cited as the Road Traffic (Prescribed Offences and Penalties) (Amendment) Regulations, 2019 and shall come into force on 1st January, 2020.
